PRP FACTORY RACE PROGRAM RULES.

Only approved members in good standing will qualify for PRP Racer Buck's. Teams must fill out a complete application and all races on application must be attended to remain a member in good standing.

ALL RACE PROGRAM PRODUCTS MUST HAVE THE PRP LOGO BRANDED IN THE APPROVED MANOR. SEATS MUST HAVE THE LOGO ON THE HEAD REST. LIMIT STRAPS, WINDOW NETS, AND SEAT BELTS MUST HAVE THE LOGO IN THE FACTORY LOCATION.

Teams must display the PRP logo on race suits; PRP will provide a PRP sew able patch. Approved PRP Logo 2.5"x10" must be located on each side of the race vehicle.

Level One participants will fill out the attached form and submit it for approval. Once approved the participant will receive a log in code to the PRP web site where they can purchase items at discounted prices through the online shopping cart. PRP race program participants will also earn PRP racer bucks credits toward inclusion in the PRP Factory Racing Level Two programs. Participants earn PRP Bucks in the following methods.

- 1.) PRP Racer Bucks Race Contingency. 200 RBs 1st in class, 100 RB's 2nd in class, 50 RB's for 3rd in class
- 2.) Retail or new distributor sales will hold a value equal to 3% of each sale. New distribution accounts will be credited to the racers ID number and will receive 3% per sale
- 3.) Entry into the PRP Factory Racer Program can be gained in two ways. Invitation by PRP Factory Racing management, or Level One Race program participants may buy into the program through performance on the race course or through marketing and sales efforts, measured with PRP racer Buck's. PRP Factory Racing buy-in is set for the 2010 and 2011 season at **\$1000 PRP Racer Buck's**.

Level Two PRP Factory Racing Teams will earn Racer Bucks the same way Level One participants earn.
